As is done every year, the students of Class XII are allowed to change the subjects within a month after the declaration of the results of Class XI Promotion Examination with prior permission from the Board. These provisions are applicable only for the students of the same stream. It has also come to the notice of the Board that some institutions are allowing their candidates to change their subjects without prior permission from the board. This is in direct violation of the Board's Regulations. Heads of institutions are to ensure that such violations are avoided so that it does not cause any inconvenience to the students.

Apart from the above, it may also be noted that the last date for the receipt of the application for changing the institution/stream with supporting documents is **30th of April** every year. However the unsuccessful candidates of the Higher Secondary School Leaving Certificate Examination are allowed to change the Institution/Examination Centre/ Stream within one month from the date of declaration of results.

The Principals of the Higher Secondary Schools and Colleges offering +2 Stage of Education are requested to kindly bring this to the notice of all concerned.
