It is hereby notified for information of all concerned that the Government of Meghalaya, Education Department has offered another chance for the Elementary School Teachers (EST) and the Pre-service Teachers Education Trainee (PSTE) to appear the HSSLC Examination in the forthcoming HSSLC Examination, 2017 at the designated Examination Centres as mentioned below:

Elementary School Teacher (EST) and Pre-service Teachers Education Trainee (PSTE) Candidates from different Districts/Sub-Divisions who have not secured 45% in aggregate are required to fill up the Examination application forms and appear the HSSLC Examination, 2017 from the institutions mentioned against the name of their respective District/Sub-Division.

The Elementary School Teachers (EST) are those who are already serving in the Elementary Schools (Government, Deficit, Adhoc/SSA/Private) and have been appointed prior to and on or after the 3<sup>rd</sup> September, 2001 but have not fulfilled the minimum qualification of securing 45% in the Pre-University/HSSLC Examination or its equivalent Examination. EST candidates who had passed the SSLC Examination but could not pursue higher studies can also directly appear in the final HSSLC Examination, 2017 to meet the minimum qualification as specified by the NCTE.

Moreover, in compliance with the Govt. of Meghalaya, Education Department's Order vide letter No. EDN. 338/2011/501 dated Shillong, the 23<sup>rd</sup> February, 2016, the Pre-service Teacher Education (PSTE) trainees who have passed the D.El.Ed but had not obtained 45% in previous HSSLC Examinations can also apply for Improvement Examination. Such candidates shall have to obtain No Objection Certificate (NOC) from the Principal of their respective DIETs (District Institute of Education and Training).

The Elementary School Teachers Candidates who had appeared in the HSSLC Examination, 2015 & 2016 but had secured below 45% in aggregate can re-appear in the forthcoming Examination in the failed subjects or can improve upon in one or two subjects or in all the subjects including the fifth additional subject. This category of candidates shall apply in the Examination Application Form as **Improvement EST Candidates**.

The Elementary School Teacher Candidates who had not attained the specified NCTE norms and who had not appeared in the HSSLC Examination (for EST), 2015 & 2016 can also appear for the said Examination after getting the necessary NOC from his/her concerned SDSEO/DSEO and enclose the necessary documents as specified below. This category of candidates shall apply in the Examination Application Form as **Fresh EST Candidates**. The Pre-service Teachers Education (PSTE) trainee candidates who wish to appear for the said Examination shall have to enclose NOC from the Principals of their respective DIETs. This category of candidates shall apply in the Examination Application Form as **Improvement PSTE Candidates**.

**Note:- BPP (Bachelor Preparatory Programme) Candidates of IGNOU are not eligible to appear the EST Examination.**

Documents to be enclosed (Photocopies):

(a) **Letter of Certificate/NOC:**

- From the respective SDEOs/DSEOs in case of **Fresh Teacher Candidates.**
- From the Principals of respective DIETs **in case of PSTE Candidates.**
- From respective Secretary of the Managing Committee and also from the SDEOs/DSEOs in case of teachers from private institutions

(b) Registration Card.


(c) Admit Cards, Marksheets and Certificates of SSLC/HSSLC.

**Note: EST Improvement Candidates of HSSLC, 2015 & 2016 are required to enclose only the marksheet of the last examination passed.**

The Elementary School Teachers Candidates shall be allowed to appear in the subjects as listed in the Guidelines/Application Forms (backside) only. The Elementary School Teachers Candidates who have already secured 45% aggregate in the HSSLC, 2016 examination will not be allowed to re-appear for HSSLC Examination, 2017.

The Examination Application Forms shall be available from the above mentioned Centres from the **17<sup>th</sup> October, 2016** onwards and submission of the forms, fees etc. by the Centres to the Board is on or before the **21<sup>st</sup> November, 2016** and with late fine on or before **30<sup>th</sup> November, 2016**.

The detailed information regarding the above matter will also be available with the Principals of the above institutions.


