1. **Mathematics** (Theory: 80 and Internal Assessment: 20)  
**Internal Assessment: 20 marks**  
Periodic tests (average of the best 2 out of 3 tests conducted) : 10 marks  
Mathematical Activities (as per scheme in the syllabus) : 10 marks

No question paper for the Internal Assessment/Practical shall be supplied by the Board.


However, the Board shall set the time table, supply the marklists, attendance sheets, answer scripts etc. for the final assessment at the HSSLC Examination Centres. Schools are to make available the marks of periodic tests and activities conducted, to the centre in **Proforma-I** attached herewith. The final assessment at the centres shall be carried out by the Internal examiners and no external examiners shall be deputed.

**e. Informatics Practices** } (Theory: 70; Practical: 30)

Evaluation scheme shall be as per the CBSE syllabus. However, the conduct of the Practical examination shall be as per the MBOSE guidelines i.e., the Board shall set the time table, supply the Question Papers, Instructions to examiners, marklist, attendance sheet, answer scripts, etc and also depute external examiners.

**d. Entrepreneurship** } (Theory: 70; Project: 30)

Project work will be assessed internally as per the scheme given in the CBSE syllabus and no question papers for Practical/Project Assessment shall be supplied by the Board. However, the Board shall set the time table and also supply the marklists, attendance sheets, answer scripts etc. for the conduct of final assessment at the HSSLC examination centres. 
