Secondary SSLC Supplementary Examination 2025.

Sir/Madam,

The Secondary School Leaving Certificate Supplementary Examinations 2025 will be conducted from the 1st May 2025. The Guidelines for registering the candidate and submission of Examination Forms and Fees for the Supplementary Candidates is published to draw the kind attention of the Officers-in-Charge and in preparing for the Board Examinations. This Guideline may be thoroughly read and understood before filling up the forms for examinations.

CATEGORY OF CANDIDATES:

Supplementary Candidates: These candidates are those who were not successful in the first SSLC examination 2025 irrespective of the number of subjects failed. It will also include those candidates who received their admit cards but were absent in the main examination. No Improvement candidates will be allowed to sit in the examination as per directives of the Education Department.

SUBJECTS FOR EXAMINATION

Subjects for examination are those in which the candidate failed in the main examination. All candidates will write for 80 marks. For those with internal/practical, the marks will be carried over. For those without internal/practical 1.25 will be added accordingly.

- The Officer-in-charge will be responsible for registering the candidates allotted to their centres
- As notified the portal for registration portal will open at 10:00 am on the 16th April, 2025 and will close on the 23rd April, 2025 at 5:00 pm
