### **NOTIFICATION NO: 679**

Dated Tura, the 23<sup>rd</sup> September, 2020

It is notified for all concerned that Vide Regulations for the Secondary School Examination, 2011 and in continuation of the Board's Notification No. 617, Dated Tura the 1<sup>st</sup> September, 2016, the fifth category, namely 'Improvement Candidate' has been included in the categorisation of candidates for the SSLC Examinations. Accordingly, following conditions shall apply for those seeking to appear the SSLC Examinations 2021 as Improvement Candidates:

1. Candidates who **have "Passed"** SSLC Examination 2020 of the Board only, are eligible to appear the SSLC Examination, 2021 as "Improvement Candidate".
2. They shall avail the provision **only once** in the ensuing SSLC Examination to be conducted.
3. The prospective candidates are to take prior permission from the Board and the last date for seeking permission has been fixed for **29<sup>th</sup> October, 2020.**
4. The candidate shall appear in the existing syllabus only.
5. Candidates are allowed to appear either in one or two or in all the subjects.
6. Candidates appearing for subjects involving practical/internal shall appear only in theory and previous practical/internal marks shall be carried forward.
7. A candidate will be issued a Mark Sheet if there is an improvement in the marks after the Improvement Examination. However, the Board shall not issue a fresh Certificate whether or not there is an improvement.
8. In the event of the candidate securing lower marks after the Improvement Examination, compared to that in the previous examination, the earlier result shall stand.
